GB INSTRUCTIONS:

- Do not forget the washers.
- Retighten all mounting bolts after the trailer hitch has been in use for approx. 620 mi (1000 km). (observe correct tightening torque!)
- The coupling ball must be kept clean and greased.
- Install the electrical system in accordance with all pertinent regulations.
- The maximum permissible towed weight is specified in your vehicle registration papers.
- If the weight of the vehicle changes, it may be necessary to recalculate the maximum permissible towed weight from the D-value. For further information, consult your specialist dealer or vehicle inspection office.
